**To the Authorized Official of Holding Companies (HCs), Foreign Banking Organizations (FBOs) and Unaffiliated State Member Banks:**

On January 18, 2018, the Federal Reserve Board approved a proposal on the *Annual Report of Holding Companies* (FR Y-6), *Annual Report of Foreign Banking Organizations* (FR Y-7), and *Report of Changes in Organizational Structure* (FR Y-10) information collection. The FR Y-6, FR Y-7, and FR Y-10 forms have been updated to reflect the current expiration date for the information collection. The form and instruction revisions to the FR Y-7 report are discussed below. **There were no other changes to the forms and instructions for the FR Y-6 and FR Y-10 reports.**

A new report item was added to the FR Y-7 to collect information from foreign banking organizations (FBOs) on compliance with applicable U.S. risk-committee and home country stress test requirements under the Board's Regulation YY and section 165 of the Dodd-Frank Act. The revisions to the FR Y-7 would implement the U.S. risk committee certification requirement in Regulation YY and provide FBOs with a standardized way to indicate compliance with the home country stress testing requirements. The FR Y-7 report revisions are effective for FBOs beginning with fiscal year end March 1, 2018.<sup>1</sup>
