Vaughan Nelson Investment Management LP (600 Travis Street, Suite 6300, Houston, TX 77002, United States) owns 2,671,357 shares or 5.90% of the stock.

There were two shareholders of record, who directly or indirectly owned, controlled Five percent or more of the common shares of the Company during 2014. Ameriprise Financial, Inc.(145 Ameriprise Financial Center, Ninneapo0lis, MN 55474, United States) owned 1,598,516 shares or 6.41%. Keeley Asset Management Corp (111 West Jackson, Suite 810, Chicago, Illinois 60604, United States) owned 1,285,534 shares or 5.2% .


