

NOTE: We were advised by counsel that Childers and Stensrud meet the SEC definition of affiliates of Coastal Banking Company, Inc. based on their influence over strategic decisions within both the bank and holding company, so we have always considered them as insiders of both entities. You are correct that neither of them are employees or officers of the holding company, Coastal Banking Company, Inc., however both are actively involved in management of both entities.
