



**FHFA House Price Index: Fifth District**





**Mortgage Distribution: Fifth District**









**Percentage of Owner-Occupied Prime Loans in Foreclosure or REO: Fifth District**





**Percentage of Owner-Occupied Prime Loans with 90+ Day Delinquency: Fifth District**





**Fifth District**






