4<sup>th</sup> Quarter, 2013  
Summary of Findings**

This report analyzes the size, composition, and performance of prime and subprime home mortgages in Maryland and the District of Columbia. It also provides information on trends in the region's housing market and charts with metropolitan area and county level data.

**State Delinquency and Foreclosure Rates**

- In the fourth quarter of 2013, foreclosure rates in Maryland and the District of Columbia mostly declined on a year-over-year basis. In addition, 90+ day delinquency rates also declined since the fourth quarter of 2012 in both Maryland and the District of Columbia.
- Since December 2012, Maryland's total foreclosure rate fell 0.6 percentage point to 2.9 percent while the 90+ day delinquency rate declined 1.1 percentage points to 3.2 percent. (Table 8)
- From December 2012 to December 2013, the total foreclosure rate in D.C. edged down from 2.2 percent to 2.1 percent while the 90+ day delinquency rate fell 0.9 percentage point to 2.4 percent over the same period. (Figure 13)
- The prime foreclosure rate in Maryland decreased from 3.2 percent in December 2012 to 2.8 percent in December 2013. Over the same period, the prime 90+ day delinquency rate edged down from 4.1 percent to 3.1 percent. (Table 9)
- Since December 2012, D.C.'s prime foreclosure rate remained unchanged at 2.0 percent and the 90+ day delinquency rate fell from 3.0 percent to 2.2 percent. (Figure 15)
- Maryland's subprime foreclosure rate declined from 12.0 percent to 6.3 percent between December 2012 and December 2013. At the same time, the subprime 90+ day delinquency rate declined 4.4 percentage points to 7.5 percent. (Table 10)
- The subprime foreclosure rate in D.C. dropped 3.2 percentage points over the year ending December 2013 to 5.7 percent while the 90+ day delinquency rate declined 1.7 percentage points to 9.2 percent. (Figure 17)
- Maryland and D.C. are ranked 10<sup>th</sup> and 30<sup>th</sup> in the nation, respectively, in their share of subprime loans. (Table 5)

**State Economic Conditions and Looking Forward**


- Rising house prices can help to reduce the possibility of mortgage default. According to the Federal Housing Finance Agency, house prices in Maryland increased 0.1 percent in the fourth quarter of 2013 and 1.7 percent on a year-over-year basis. Meanwhile, home values in D.C. appreciated 0.2 percent in the fourth quarter of 2013 and 8.9 percent over the year.
- An income shock to a household—such as unexpected unemployment—can affect the household's ability to repay a mortgage. In December 2013, the unemployment rate (NSA) in Maryland was 5.7 percent, remaining below the national 6.5 percent mark, while in D.C. the jobless rate was 6.9 percent. (Table 12)



**Mortgage Distribution: Maryland**





**3a: Mortgages Outstanding**




**3b: Foreclosure Inventory**

**Percentage of Owner-Occupied Loans in Foreclosure or REO<sup>1</sup>: Maryland and DC**





**Maryland and DC**





**Maryland and DC**





**Maryland and DC**





**Maryland and DC**





**Maryland and DC**








**Figure 12**








**Figure 16**






