



**FHFA House Price Index: North Carolina**





**North Carolina**



**Percent Delinquent by Zip Code**



**North Carolina**



**Percent Delinquent by Zip Code**



**North Carolina**


**Percent in Foreclosure or REO by Zip Code**



**Percent Delinquent by Zip Code**







Owner-Occupied Loan Statistics: North Carolina**





**Owner-Occupied Prime Loan Statistics: North Carolina**





**Owner-Occupied Subprime Loan Statistics: North Carolina**






