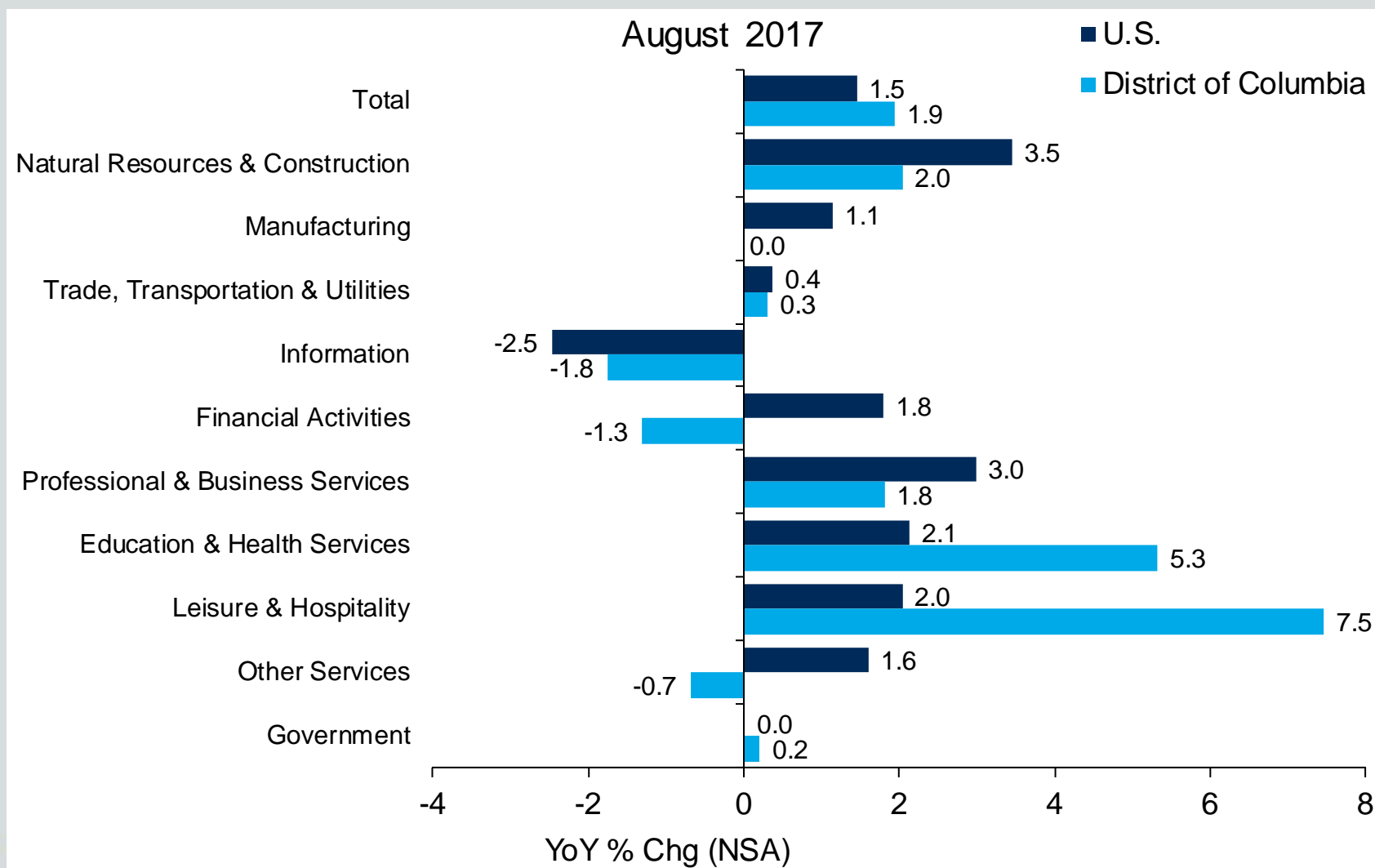
Percent Change in Employment from a Year Ago, NSA

Percent Change in Employment from a Year Ago, NSA



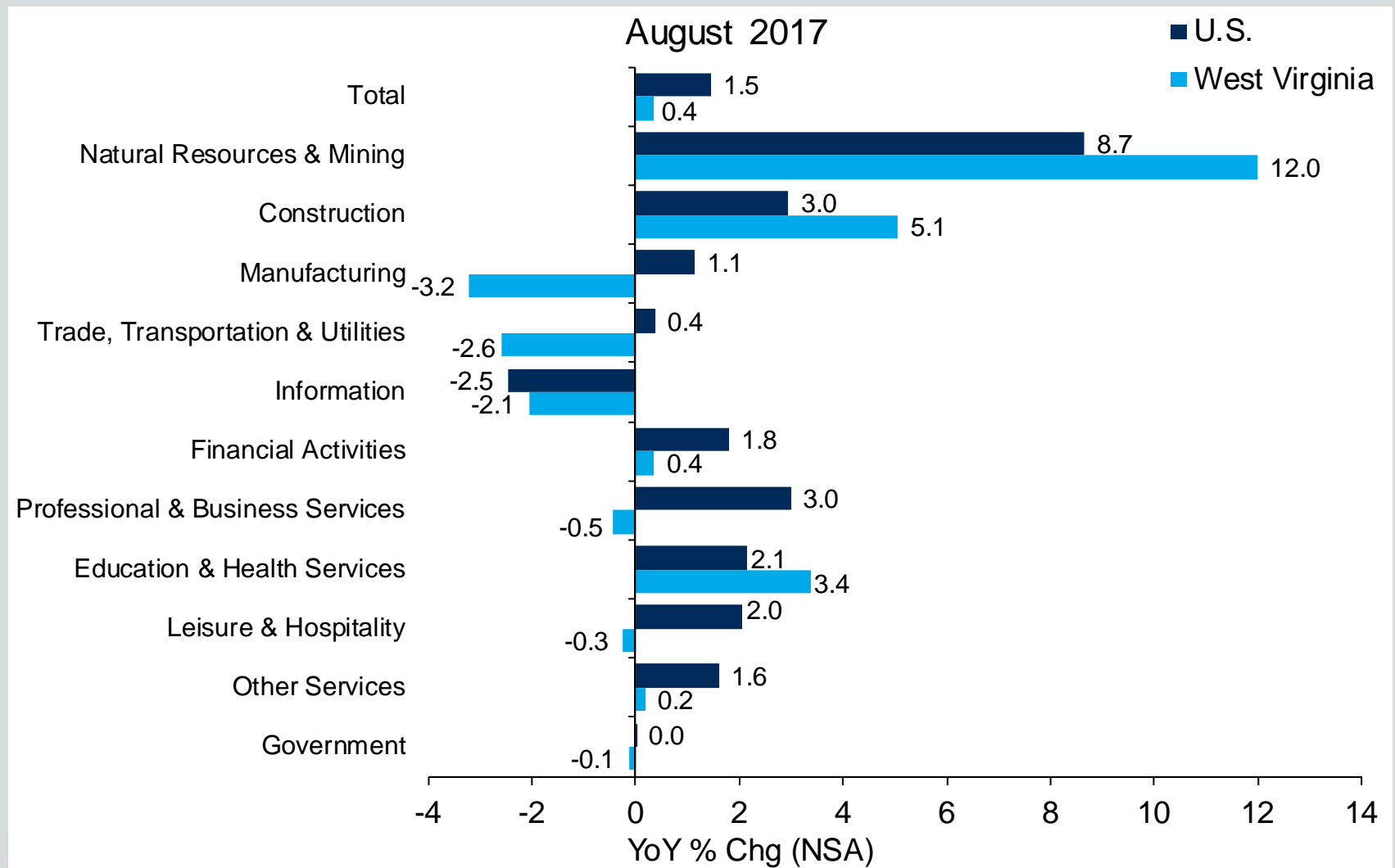

Percent Change in Employment from a Year Ago, NSA



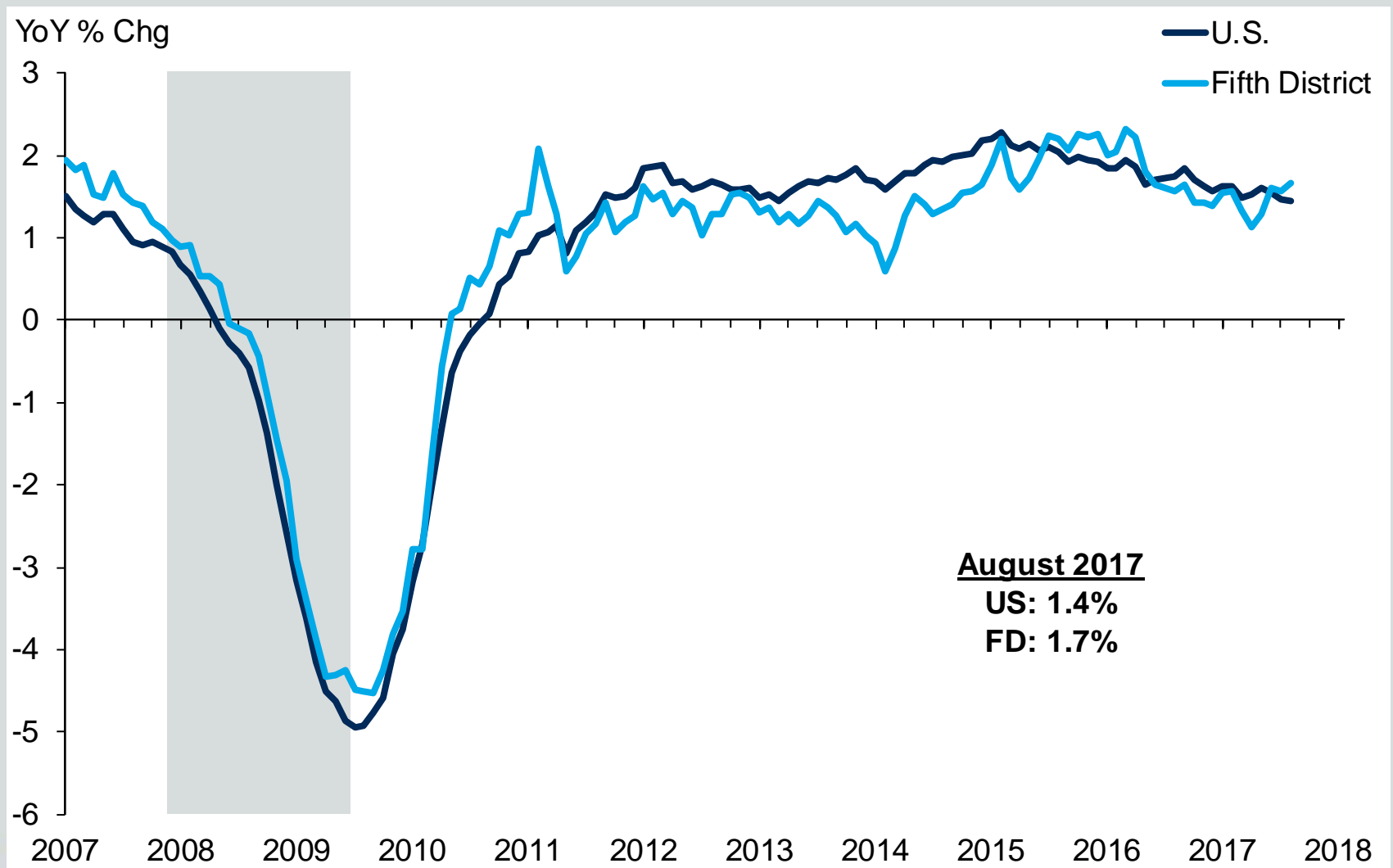

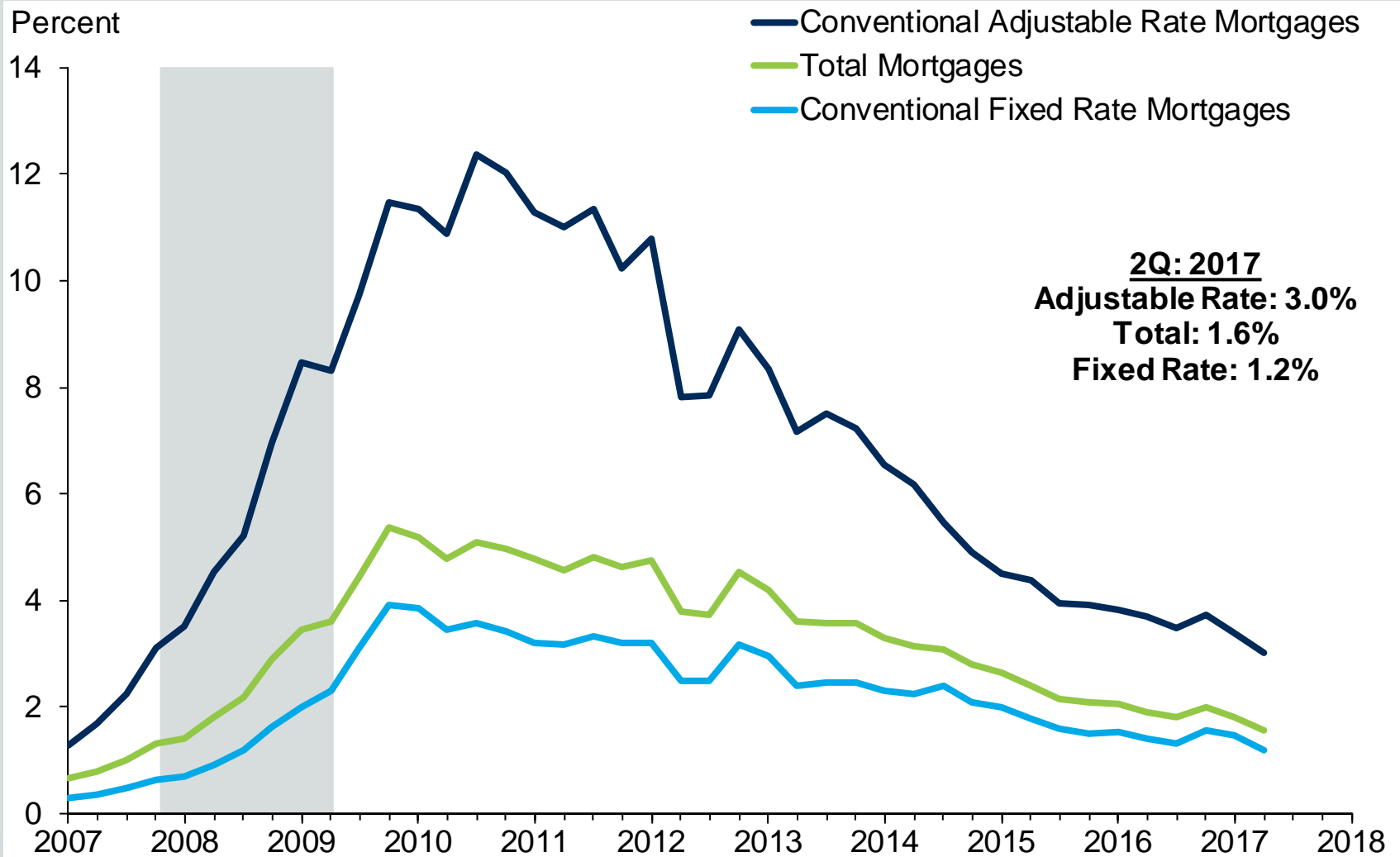
